## Notes from Informational Meeting Thursday December 1, 2016

205 members in good standing-41 needed for a quorum- 27 in attendance-no quorum

<u>Call to Order-</u> President Gilliland called the meeting to order at 2:30 PM.

**Pledge and Prayer-** Judy Griffith gave the invocation.

**Roll Call-** Present were President Gilliland, Vice President Griffith, Treasurer Holder and Secretary Huff. Director Lacourse was in attendance. Absent was Director Sims, Director Burchfield and Director Grogan.

<u>Secretary's Report-</u> The notes from the November 3, 2016 informational meeting were read.

<u>Treasurer's Report-</u> Treasurer Holder reported the balance in Water is \$20,301.00, the balance in Inc. is \$34,437.00. and the reserve account balance is \$6,698.00. Treasurer Holder reported that she has prepared the 2017 budget, and included is funding to make street repairs.
