JOHN THEN MADE A MOTION TO PAY FRWA \$1250 TO BEGIN THE PROCESS, FOR ENGINEERING SERVICES FOR THE REPLACEMENT OF THE WATER SYSTEM AND PUT US ON THE PRIOROTY LIST, THE MOTION WAS 2<sup>ND</sup> BY RODNEY AND THE VOTE WAS 5 TO 4 IN FAVOR AND THE MOTION WAS CARRIED.

JOHN BROUGHT UP NANCY MCGRATH'S 90 DAY REVIEW, PAULINE GAVE A REVIEW OF THE WORK THAT NANCY DOES IN THE OFFICE.

JOHN MADE A MOTION TO HAVE A 1 YEAR REVIEW ON PAULINE AND NANCY, THE MOTION WAS  $2^{\text{ND}}$  AND WAS VOTE YES BY ALL 7 BOARD MEMBERS AND IT WAS PASSED.

POT HOLE REPAIR, WATER TURNOFF/ON AND HOME MONITORING. IF TENNANT PAYS THEIR SHARE (\$14/MONTH) OWNER WILL GET THE VOTE AND TENNANT WILL BECOME A FULL MEMBER. MOTION SECONDED AND PASSED 7 TO 0, MOTION PASSED
