Notice of Mobile Manor Inc. Special Election:

The Mobile Manor Board of Directors & Bylaw Committee has determined that we need a bylaw change to the existing bylaws to clarify the revised election process. The revision to be voted on only concerns the election process for future bylaws and board members. The election will be held on December 5th, at the community meeting in accord with the below cited Article X, Section 1.

Article X: AMENDMENT OF BYLAWS (current 2018 bylaw)

Sec. 1. Upon proper notice, the bylaws may be amended, altered or rescinded by a ¾ vote of a required quorum of 35 voting members in attendance, provided a written notice has been delivered or mailed to all voting members of intent to amend bylaws at least twenty (20) days before the date of such meeting. Proxy forms will be accepted.
