Call to Order: President Gilliland called the meeting to order at 2:30 PM

2015 Budget

Mrs. Holder presented the 2015 Budget that had been distributed to all members. The Inc. budget projects Income of \$79,440 and Expenses of \$64,240. The Water budget projects Income of \$74,300 and Expenses of \$71,950.

Motion was made and duly seconded that the 2015 Budgets be approved as presented.

Social Club: Nancy McGrath, Social Club President reviewed the events scheduled for the month.

<u>Web Site:</u> Mr. Burchfield reviewed features of the site including the new garage sale and real estate pages.

Board of Directors Update: Mrs. Holder gave the following report.

Roads: The sealcoating of the East Park has been completed and only one resident was not pleased. There was discussion on speed limits and/or speed bumps. This will be put on as a study item. It was agreed that a decision on this issue should be made prior to proceeding with any future road improvements.

A review of the issue of road ownership has been completed and it revealed that residents do own to the center of the road however there is a "granted easement" and therefore Mobile Manor can improve the roads.

Community Center Security/Keys: This was put on as a study item to be discussed at the February Board meeting.

Other: A letter from a resident, to the Board, regarding her view of the Park, past and present was read and at her request it will be forwarded to Tim Burchfield for incorporation into the newsletter.

A review of the Florida Statutes regarding the procedures that would be required to place covenants on properties has been done. This will be listed as a study item for the 2015 Board to discuss.

Rental Participation Issue was again discussed without any resolution. It was suggested that it be discussed at the March Community Meeting. The manner of how to frame the discussion will be listed as a study item and discussed at the February Board meeting.
