<u>Busíness</u>

At the January Community Meeting Denise Sabatini from Lee County's Municipal Services Taxing/Benefit Unit (MSTBU) made a presentation regarding the cost to everyone in the community should we have to abandon the water company. Her title is MSTBU Coordinator. The MSTBU assists citizens in the unincorporated areas of Lee Count-

ty to obtain services which aren't províded by Lee County, in this case, the overhaul of our park's water system. In our situation, the opinion of the MSTBU is the only one that counts. Lee County Utílítíes can't tell us what the costs will be unless they get it from MSTBU. Your best friend's cousin who is in construction can't tell us. And, what happened in another park last year doesn't really matter. MSTBU working with an independent engineer studied our case and estimated that it would cost \$2,693,886. (That's construction costs plus administration costs plus capitalized interest costs.) That translates to \$8,392 per property. This can be paid at one time or amortized over 15 years. The latter would require interest which is estimated to be \$5371 at current rates. Denise Sabatini mentíoned a couple of other costs as well. Each property owner would be responsible for connecting their water pipes to the updated system. She didn't estimate what that would be: however, she did say that there would be a \$4000 to \$5000 "capacity cost" per property that needed to be paid to Lee County Utílítíes. Subsequently, we have been informed that the bulk of this latter amount has previously been paid. Thus, the "capacity cost" has been reduced to \$320 (Water Deposít-\$60, Water Tap/ Drop-ín Fee-\$260). We'd líke to thank Ms. Sabatini for her efforts.
