The maintenance fee for 2016 is \$28.00 per month (\$336 per year). If you are one of the approximately 200 owners who pay main-

tenance fees, thank you so much. You may do so at the Mobile Manor office during regular office hours or through the mail. If you are one of the approximately 100 owners who do not pay maintenance fees, please consider doing so. We are in the process of upgrading security in Mobile Manor and can really use the additional help. For those who help pay for the security street lighting, thank you because our electric bill alone exceeds \$12,000 annually. However, the need for additional funds goes beyond more security. For instance, other expenses which include accounting, legal, payroll, office, telephone, and administrative costs exceed \$20,000 annually; grounds, building, street, bridge repair and maintenance plus pest control also exceed \$20,000; and taxes, insurance, licenses/permits, and workers comp exceed \$16,000. So, again, we can use more help.

Please make every effort to attend the Annual Community Meeting on Feb. 4<sup>th</sup>. We will need a quorum of at least 60 eligible maintenance paying households in order to officially conduct business.

You may have noticed that the Board of Directors sponsored the New Year's Dinner last month and they are also offering a spaghetti dinner this month. These events are in addition to events presented by the Social Club. The proceeds from these dinners and future ones are being deposited into a Benevolent Fund which will only be used to help residents in need. For instance, a resident with a very restricted income recently had a plumbing problem on their property. It was their responsibility to fix, but they didn't have the money to do it. The Board was able to help. Other than using the clubhouse and kitchen for these events, no Mobile Manor Inc. or Mobile Manor Water resources are or will be used and the proceeds won't be used for any other purposes. Also, this help will be kept strictly confidential regarding who receives it.



<u>Rumor</u>-The Board is trying to form an HOA.

**<u>Status</u>**-False. The Board formed a committee in order to gauge

the community's interest in implementing deed restrictions. They can be enforced by using an HOA, but that's not the only way. Committee chairman, Butch Sims, wrote a letter which you should have received with the newsletter explaining three options regarding whether the community wants deed restrictions and the possible methods of enforcement. The committee values your input and hopes you will respond regarding your preferences. You will not be bound in any way by your responses.

Chílí

1 lb. ground beef 1/2 C. díced oníons 1 jar (16 oz.) salsa 1 can (10 oz.) díced tomatoes w/ chiles 11/2 t. chílí powder 1/2 t. ground cumín 2 t. Worcestershire sauce 1 T. sugar

Brown the meat with onion. Drain well. Add all remaining ingredients. Cover and cook on low for at least 4 hours. Stir occasionally.
