**B-17 Flying Fortress** Here are two more World War II era veterans that we'd like to honor. Ted **Randolph** was only 17 when the war ended, but he served in an Army MP attachment in 1946 and received the WWII victory medal. Ralph Bruhn was in the U.S. Army Air Forces' 8th Air Force. From late summer 1944 to V-E Day, May 7, 1945, Ralph flew 30 bombing missions from bases in England to varíous locatíons in Western Europe including Germany. On 7 of those missions Ralph was in the lead plane which was always a high-risk situation. He was part of a 9 man crew flying B-17 Flying Fortresses. He was a Lower Ball Turret

Gunner. On New Year's Day, 1945, his plane suffered heavy damage and was forced to turn back. It steadily lost altitude.



When it came out of the clouds at 2000' they found themselves eyewitnesses to the largest and bloodiest battle in WWII-The Battle of the Bulge. They also became the target for most of the German forces left in France. Fortunately, no more damage was done and they landed at a small British airfield in Lille, France from where they made it safely back to England. Thank you for your service.

Mobile Manor Social Club Meeting March 5, 2013 @ 10 am Everyone is welcome.

At the February Community Meeting the result of the recent park-wide vote was announced. There were 6 votes for Option #1 and 167 for Option #2 with 139 ballots not returned. Because of the inconclusive nature of the vote, the fees paying members of the community voted to approve an annual budget of \$66,789.55 and to pay \$28.13 per month (\$337.56/yr) in maintenance fees. The next meeting will be held @ 2:30 pm on March 7th. Everyone welcome.

What will happen to those among us who truly have a hard time making ends meet should they have to face a huge assessment for a new water system? (Are you aware that some of us have paid double maintenance fees to help those in need and supplement the "non mandatory" payment system?) So please, let me know how you feel we can repair our community. Let's get a dialog started before it's too late.
