The "Mobile Manor Survey on Deed Restrictions" which was recently distributed to the community resulted in 81 responses including 3 emails. This was somewhat disappointing since 275 surveys were sent out. The results were as follows: 26 responders were interested in Option 1, 25 in Option 2, and 30 in Option 3. Because of the limited response, the Board decided to keep the committee intact, but to table the issue for now. That allows the committee to meet occasionally and to resume the process easily. ## Mobile Manor 101

(Thanks to Kathy Holder for this article.) Mobile Manor subdivision consists of two very distinct corporations. Mobile Manor, Inc. (MMI) and Mobile Manor Water Inc. (MMW). The elected board of MMI is also the governing body of MMW. MMI has by-laws under which it operates. Members have an opportunity to take part in Community Meetings. An annual meeting must be held in February. The Board must seek approval of the membership on contracts over \$2,000. Mobile Manor is a 55 and older community and, as such, must register with the State of Florida and keep a census regarding the ages of the residents. MMW's regulations come from both the Public Service Commission and the Lee County Health Department and they are numerous. MMW is not governed by any of MMI's bylaws. MMW is only obligated to report once a year, nevertheless, a financial and activity report is given at each Community Meeting. Each corporation maintains its own bank accounts; however, they do interact in the following ways: (1.) MMW has a formal agreement with MMI to share office space. (2.) MMW and MMI contract with the same accounting firm. (3.) MMW and MMI share the cost of the Office Manager's salary.

Here's an oldie but goodie. I remember my Mom making this back in the '40s <u>Cíty Chícken</u>

1/2 lb. pork 1/2 lb. veal 1 egg, beaten Bread crumbs (seasoned if you want) 1 c. milk

Heat oven to 350 degrees. Cut pork and veal into 1" cubes. Thread on bamboo or wooden skewers, alternating chunks of pork and veal. Dip the skewers in the egg, then the bread crumbs, to coat. Sauté until browned. Put skewers in a baking pan, and add milk. Cover in foil, and bake about 1 hour.

#### "It's a Funny Life"

A simile is a figure of speech comparing two unlike things. It's intro-

duced by "like" or "as". For example, "She's as fierce as a tiger" is a simile. A metaphor is implicit and doesn't use "like" or "as". For example, "She's a tiger when she's angry" is a metaphor. But enough English lessons. My favorite simile of all time was provided by a classmate of mine named Dave Hunter when we were both in Mrs. Talbot's English class in high school.
